1. Using your current or prior billing cycle water bill, locate the **Usage** number for your residence. This number is in units of water and needs to be converted to gallons for the calculations.

2. Multiply your usage number by **748** to convert it to gallons of water.

3. Since our billing cycle is bi-monthly, you will need to divide your gallons calculation by **60** in order to find the gallons per day for your household.

Sometimes the service period is shorter or longer than 60 days. If you want a more exact number, you will want to calculate the number of days in your specific **service period by locating your period on the bill and seeing how many days elapsed during that time.*

4. To determine your R-GPCD number, you then take your gallons per day calculation and divide by the number of people who live in your household. This final number is your R-GPCD number and will guide you as to how your household is doing in regards to conservation and water usage.

Examples:

Usage of **38** with **3** people living in the home would have a calculation of
38 units x **748** gallons = 28,424 gallons ÷ **60** days = 473.73 gallons/day ÷ **3** people = **157.91 R-GPCD**

Usage of **53** with **4** people living in the home would have a calculation of
53 units x **748** gallons = 39,644 gallons ÷ **60** days = 660.73 gallons/day ÷ **4** people = **165.18 R-GPCD**
